BACKGROUND:

On February 27, 1986, the Board of Supervisors adopted Resolution 86-103, which established CSA 145 (Sun City) to provide street light and park and recreation services. Due to increased development in the Sun City area, the Economic Development Agency has identified the need for the proposed addition of landscape maintenance service. Pursuant to Government Code 25210.31, the Board of Supervisors may add extended services within an established County Service Area if determined to be a public convenience and necessity. The adoption of Resolution No. 2004-276 will set a public hearing to receive community input relating to the extended service.

6 **WHEREAS**, the Board of Supervisors established County Service Area
7 No. 145 (CSA 145) in the unincorporated area of Riverside County now encompassing Sun City
8 for the purpose of providing extended park and recreation and streetlight services; and

10 **WHEREAS**, Government Code Section 25210.31 allows for adoption of a Resolution of
11 Intent to provide additional extended services within an existing County Service Area; and

12 **WHEREAS**, it has been requested that landscape maintenance services be added to CSA
13 145;

15 **NOW, THEREFORE**, be it resolved by the Board of Supervisors of the County of
16 Riverside, State of California, in regular session assembled on June 22, 2004 that this Board
17 will conduct a public hearing on July 27, 2004 at 9:30 A.M. to determine whether extended
18 landscape maintenance services should be added to CSA 145.

19 **BE IT FURTHER RESOLVED** that payment for such extended landscape maintenance
20 services shall be provided to County Service Area 145 and shall be paid from service charges
21 collected pursuant to Government Code Section 25210.77a.

23 **BE IT FURTHER RESOLVED** that the Clerk of the Board is to give notice of the
24 proposed public hearing pursuant to Government Code Section 25210.33
