SUBJECT: Notice of intention to change the name of Cloverdale Road to Limonite Avenue in the Mira Loma Area, Second Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2004-088, Notice of Intention to Change the Name of Cloverdale Road to Limonite Avenue in the Mira Loma Area.

BACKGROUND: Cloverdale Road from Hamner Avenue to Archibald Avenue is the extension of the Limonite Avenue Alignment westerly from Hamner Avenue. Due to development in this area Hamner Avenue is no longer a logical break point for the street names. Having the entire length of the road named Limonite will eliminate confusion in the area. There are currently thirteen property owners with Cloverdale Road addresses.

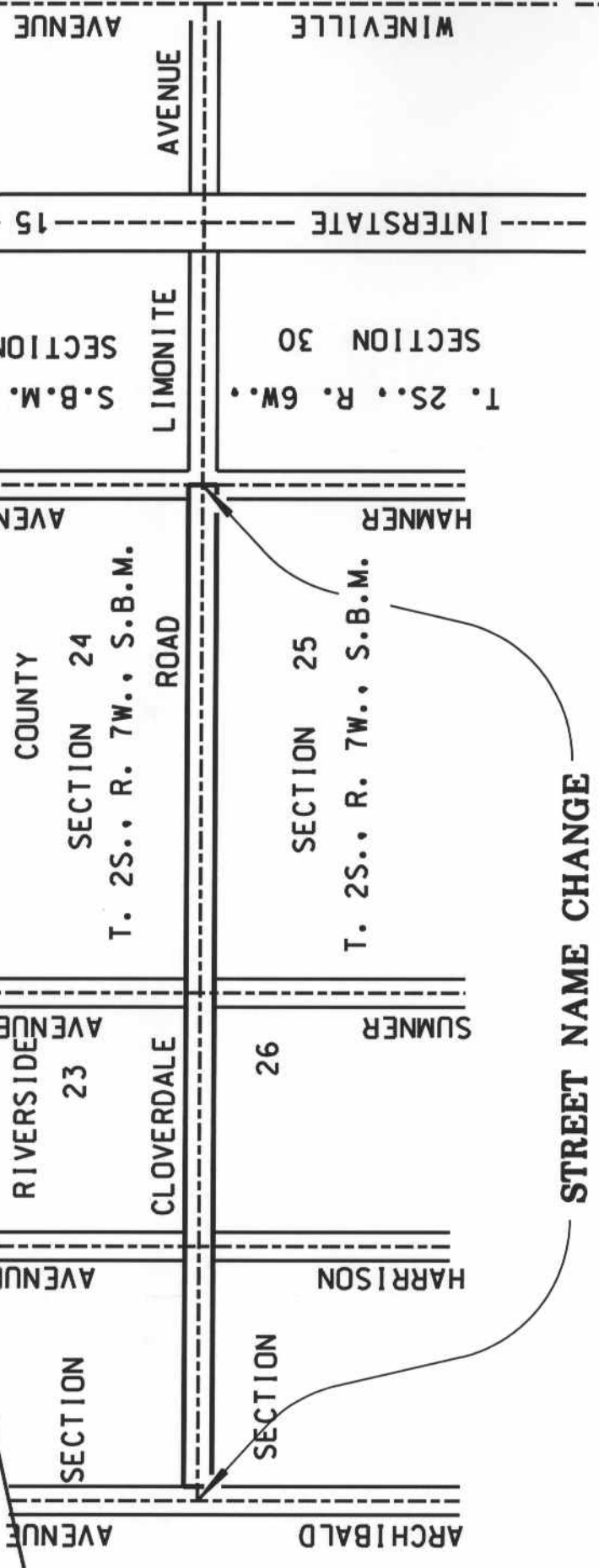
