Departmental Concurrence

BACKGROUND: The Children's Dental Disease Prevention Program was previously funded by the State of California for Fiscal Years 2002 through 2004, in the total amount of \$250,858. The State of California now requires the Board of Supervisors authorize the Community Health Agency to apply for continued funding; and that the Chairperson of the Board of Supervisors be authorized to execute the resulting agreements and amendments via resolution. A copy of this resolution is required to be included in the application for grant funding. If successful in securing an award, net county cost will be \$15,452 per year (9.07%). This is included in the FY 2004-05 proposed budget.

16 Director of Public Health to submit an application to the California Department of Health Services for the
17 Children's Dental Disease Prevention Program for Fiscal Years 2004 -2007.

19 authorized to execute the resulting contract and any amendments thereto, if the allocation or a part thereof,
20 is awarded to County of Riverside Community Health Agency/Department of Public Health, a copy of said
