RECOMMENDED MOTION: Move that the Board of Supervisors:

- (1) assess the reasonable costs of abatement of a public nuisance (excess outside storage of materials) in the above-referenced matter to be twenty-four thousand, seven hundred, seventy-seven dollars and thirty cents (US \$24,777.30);
- (2) assess the costs of abatement against the above-described subject property;
- (3) authorize the recordation of a notice of abatement lien; and
- (4) authorize the abatement costs to be added to the tax roll as a special assessment.


BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 348 (RCC Title 17) and 725(h-1) (RCC Chapter 1.16) authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

The Board of Supervisors issued an Order to Abate Nuisance in this case on August 28, 2001. On or about September 3, 2002, the property was brought into compliance under the direction of Riverside County Building and Safety Code Enforcement pursuant to a seizure warrant.

This property has a delinquent tax status as of 1998.

All notices regarding the Statement of Expense hearing have been given to Josephina Garcia, the property owner, as required by law (see attached exhibits).
