**SUBJECT:** Acceptance of a 2004 Grant Award from the U.S. Department of Justice, Drug Enforcement Administration for a Cannabis Eradication/Suppression Program

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Approve an Agreement, accepting an award of \$70,000 from the 2004 Domestic Cannabis Eradication/Suppression Grant Program of the U.S. Department of Justice Drug Enforcement Administration (DEA), and authorize the Chairman and Sheriff to sign the Letter of Agreement No. 2003-28 on behalf of the County.
2. Approve and direct the Auditor-Controller to make the budget adjustments on the attached Schedule A.

**BACKGROUND:** Over the last seventeen years, the County has received funding from the Domestic Cannabis Eradication/Suppression Grant Program. To a large extent, the Sheriff's Department uses these funds to defray the cost of Deputy and Investigator overtime expended in its cannabis eradication effort. The Department also sends the DEA samples of the confiscated marijuana to the National Institute of Drug Abuse Potency Monitoring Program.

In calendar year 2004, the DEA has awarded the Sheriff's Department \$70,000. County Counsel has approved the Agreement documents and required certifications as to form.
