**BACKGROUND:**

The 45<sup>th</sup> Street Project (Project) is located between Agate St. and Vernon Avenue within the community of Glen Avon. This road is heavily used by residents in the Jurupa Valley Redevelopment Project Area and the Project will greatly improve transportation conditions. The Project will include the construction, construction survey and related services as detailed in Exhibit "A."

The attached Agreement between the RCTD and the Agency provides funding for the Project in order to facilitate the street improvements. County Counsel has approved the attached agreement and staff recommends approval.
