SUBJECT: Public Hearing-Extended Services within County Service Area No. 145

RECOMMENDED MOTION: That the Board of Supervisors:

1. Conduct the public hearing; and
2. Upon the close of the public hearing, adopt Resolution No. 2004-277, Authorizing the Addition of Extended Services within County Service Area No. 145.

BACKGROUND: On February 27, 1986, the Board of Supervisors adopted Resolution 86-103, which established CSA 145(Sun City) to provide street light and park and recreation services. Due to increased development in the Sun City area, the Economic Development Agency has identified the need for the proposed addition of landscape maintenance service. Pursuant to Government Code 25210.31, the Board of Supervisors may add extended services within an established county service area if determined to be a public convenience and necessity. The adoption of Resolution No. 2004-77 will authorize CSA 145 to provide landscape maintenance service.

2 RESOLUTION NO. 2004 - 277

3 AUTHORIZING THE ADDITION
4 OF EXTENDED LANDSCAPE MAINTENANCE SERVICES WITHIN
5 COUNTY SERVICE AREA NO. 145

6 **WHEREAS**, Government Code Section 25210.4 and 25210.31(a) authorizes the County
7 to provide the extended governmental services within an established County Service Area; and

8 **WHEREAS**, it has been requested that the extended service of landscape maintenance be
9 added to CSA 145; and

10 **WHEREAS**, a public hearing was conducted by this board on July 27, 2004 after
11 which this Board determined that public convenience and necessity require that extended
12 services should be added to CSA 145.

13 **NOW, THEREFORE**, be it resolved by the Board of Supervisors of the County of
14 Riverside, State of California, in regular session assembled on July 27, 2004 that extended
15 service of landscape maintenance should be added to CSA 145.

16 **BE IT FURTHER RESOLVED** that such extended services shall be provided locally
17 within the geographical boundaries of CSA 145, and that such payment for said extended
18 services shall be made from an assessment collected pursuant to Section 25210.77(a) of the
19 Government Code.
