SUBJECT: Ratify the Renewal Agreement with Second Harvest Food Bank, and Desert Alliance for Community Empowerment RANCHO Housing Alliance, FY 2004/05 for Community Services and Senior Center Support, in all of Riverside County.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the attached renewal agreements with Second Harvest Food Bank, and Desert Alliance for Community Empowerment RANCHO Housing Alliance.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: These agreements represent the last year of the four year 01-05 RFP contracting cycle.

These renewals (see: Attachment A) with Second Harvest Food Bank, and Desert Alliance for Community Empowerment RANCHO Housing Alliance, covering the period July 1, 2004 through June 30, 2005, in the reimbursable amount of \$100,000 for Material Aid to seniors of Riverside County. Material Aid services arrange for and assist participants in the form of USDA commodities and surplus food distribution.
