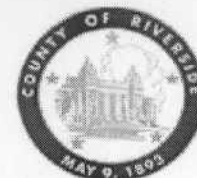

**SUBJECT:** Ratify the Renewal Agreement, with Inland Caregiver Resource Center, Care Connexus, Inc., Family Service Association of Western Riverside County, and Developing Aging Solutions with Heart, Inc., FY 2004/05 for Caregiver Program covering all of Riverside County.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the attached renewal agreements with Inland Caregiver Resource Center, Care Connexus, Inc., Family Service Association of Western Riverside County, and Developing Aging Solutions with Heart, Inc.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

**BACKGROUND:** These agreements represent the last year of the four year 01-05 RFP contracting cycle.

These renewals (see: Attachment A) with Inland Caregiver Resource Center, Care Connexus, Inc., Family Service Association of Western Riverside County, and Developing Aging Solutions with Heart, Inc., covering the period July 1, 2004 through June 30, 2005, in the reimbursable amount of \$250,000, continues the Caregiver Program for all of Riverside County.

The caregiver program targets, both caregiver and care receivers, in Riverside County, especially those in hard to reach or underserved populations. Assistance in the form of counseling, support groups, training, and respite care.
