SUBJECT: Ratify the Renewal Agreements, with Care Connexus, Inc., Eisenhower Medical Center, and Family Service Association of Western Riverside County, FY 2004/05 for Alzheimer's Day Care Resource Center.

- RECOMMENDED MOTION:** : That the Board of Supervisors:
- 1) Ratify the attached renewal agreements with Care Connexus, Inc., Eisenhower Medical Center, and Family Service Association of Western Riverside County.
 - 2) Authorize Chairman of the Board to sign the agreement.
 - 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: These agreements represent the last year of the four year 01-05 RFP contracting cycle.

These renewals, (see: Attachment A) with Care Connexus, Inc., Eisenhower Medical Center, and Family Service Association of Western Riverside County covering the period July 1, 2004 through June 30, 2005, in the reimbursable amount of \$240,000, continues the provision of Alzheimer's Day Care Resource Center (ADCRC) to the seniors of Riverside County. This program targets seniors with moderate to severe dementia, providing day care services necessary to meet their physical and psychosocial needs. This program also: provides training for professional, students, and caregivers; disseminates information to the public regarding Alzheimer's disease and related disorders; ensures availability of family support groups; and provides services to assist family members, including counseling and referral to other resources
