RECOMMENDED MOTION: That the Board of Supervisors:


- 1) Ratify the attached renewal agreements with Care Connexus Inc., Developing Aging Solutions with Heart, Inc., Eisenhower Medical Center, and Family Service Association of Western Riverside County.
- 2) Authorize Chairman of the Board to sign the agreement.
- 3) Direct the Clerk of the Board to retain one (1) original copy and return two (2) copies to the Office on Aging for further processing.

BACKGROUND: These agreements represent the last year of the four year 01-05 RFP contracting cycle.

These renewals (see: Attachment A) with Care Connexus Inc., Developing Aging Solutions with Heart, Inc., Eisenhower Medical Center, and Family Service Association of Western Riverside County covering the period July 1, 2004 through June 30, 2005, in the reimbursable amount of \$130,107 continues the Adult Day Care Program for seniors of Riverside County.

The Adult Day Care Program Allows Riverside County seniors to maintain optimal capacity for self-care and continue to live in the community, rather than placed in a long-term care institution.
