SUBJECT: Ratify the Agreement with Inland Empire Health Plan (IEHP) to provide urgent care services to IEHP members at the Urgent Care Clinic located at the Riverside Neighborhood Health Center.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Ratify the Agreement with IEHP for the performance period of March 1, 2004 and shall renew automatically for subsequent one (1) year period for up to five (5) years thereafter, unless sooner terminated;
2. Authorize the Chairperson of the Board of Supervisors to sign four (4) original Agreements on behalf of the County; and
3. Direct the Clerk of the Board of Supervisors to return all four (4) original Agreements to the Community Health Agency Contracts Administration for further processing.

SUBJECT: Ratify the Agreement with Inland Empire Health Plan (IEHP) to provide urgent care services to IEHP members at the Urgent Care Clinic located at the Riverside Neighborhood Health Center.

BACKGROUND: The Community Health Agency (CHA) already contracts with IEHP to provide primary care services to those IEHP members who select the Riverside County Clinics as their primary care providers. Because the Riverside County Neighborhood Urgent Care Clinic is open evenings and weekends, this Agreement will allow the Urgent Care Clinic to see other IEHP members who are not able to see their own doctors for after hours services. CHA will be paid fee for service by IEHP for each of these visits. Approximately \$50,000 in additional revenue will be generated for Riverside County.

This Agreement has been approved as to form by County Counsel.
