BACKGROUND:

On February 24, 2004, Agenda # 3.26, the Board entered into a Grant Agreement with HUD and a Sponsor Agreement with ABC Recovery to operate a Supportive Housing Program to provide transitional housing to chronic substance abusers in Riverside County.

On July 22, 2004, HUD approved an amendment requested by DPSS to move \$5,200 from the Supportive Services budget to the Operations budget, which we are submitting to your Board for approval. This amendment was necessary to bring the budget in line with the actual activities of the Supportive Housing Program operated by ABC Recovery. The effective date of this change is May 1, 2004.
