SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT AGREEMENT—OPERATION SAFEHOUSE

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program (SHP) Grant for \$135,756 for the period of March 1, 2004 through February 28, 2005.
2. Authorizes the Chairman of the Board to sign the attached Contract, HU 1660-00, between DPSS and Operation Safehouse.
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Operation Safehouse, not to exceed the maximum amount of the Grant Agreement (\$135,756) ; and
4. Authorizes the Director of DPSS to administer the agreement with Operation Safehouse.

BACKGROUND:

On July 1, 2003, (Agenda Item 3.49), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a supportive housing program operated by Operation Safehouse. HUD approved the application and allocated \$135,756 for a 1-year period. Operation Safehouse provides transitional housing for homeless youth.

HUD approved the funding agreement on August 6, 2004, which we are submitting to your Board for approval along with the County's agreement with Operation Safehouse.

FINANCIAL DATA: No County General Funds are required.
