BACKGROUND: On April 5, 2004, the Board approved the plans and specifications for the State Highway 60 Interchange Beautification Project and authorized the Clerk of the Board to advertise the Notice Inviting Bids for the project. The Riverside County Transportation Commission (RCTC) approved funding for the project in the amount of \$1,621,000 on January 12, 2002, which will be reimbursed to the Agency after completion of construction as part of the Federal Transportation enhancement Activities Program. The project improvements will include landscape improvements to five interchanges including along the 60 freeway including Van Buren Boulevard, Etiwanda Avenue, Country Village Road, Pedley Road and Pyrite Street, in unincorporated Riverside County.

The Notice Inviting Bids for the project was advertised from May 4, 2004 to June 1, 2004. On July 8, 2004 at 2:00 pm, bids were received. The low bid was received from Tony's Landscaping Inc. for \$5,650,495.00. After a detailed review, County Counsel and Agency staff has determined that the bid is responsive and complete. Therefore, Agency staff recommends that the Board award the contract to the lowest, qualified and responsive bidder, Tony's Landscaping Inc., in the amount of \$5,650,495.00.
