**SUBJECT:** Fifth amendment to the agreement between Sourcecorp Healthserve and RCRMC.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the fifth amendment to the agreement between Sourcecorp Healthserve and RCRMC for the performance period of July 1, 2004 through June 30, 2005;
- 2) Authorize the Chairman to execute the amendment;
- 3) Direct the Clerk of the Board to retain one (1) original and return two (2) original copies of the amendment to RCRMC.

**BACKGROUND:** In the development of RCRMC's Diagnostic Imaging Department it was determined that a new form of imaging would be adopted. This imaging differs in that it utilizes computers to generate, visualize, and store images. As part of this new imaging process a method was required to convert hard copy files into electronic images and send to the new facility on demand. At that time Sourcecorp Healthservice was identified as the only provider of this service.

**BACKGROUND (Continued):** The Board first approved the agreement on December 16, 1997 item number 3.15, the agreement was first amended by the Board July 20, 1999 item 3.23, a second amendment was approved May 15, 2001, item 3.23, a third amendment approved June 25, 2002, item 3.48 and a fourth amendment approved February 24, 2004 item 3.31. Sourcecorp Healthservice is responsible for storing, handling, delivering both physically and electronically thirteen years of patient images on demand. So as not to compromise patient care, RCRMC has requested a one year renewal with the current vendor. In that time a formal request for proposal shall be conducted with the assistance of County Purchasing to research the market again, for a suitable vendor.

**PRICE REASONABLENESS:** This Fifth Amendment is to renew Sourcecorp Healthcare's agreement for an additional year at the same vendor rates. RCRMC's Diagnostic Imaging Department has completed a reengineering of the workflow process to decrease the contracted handling fees. As a result of the decreased handling fees, the combined expense under the agreement with Sourcecorp Healthcare is estimated to be less than previous fiscal years.
