SUBJECT: Ratify the Third Amendment to the Agreement with Animal Friends of the Valley.

BACKGROUND: (Continued)

Animal Friends of the Valley (AFV) is a non-profit animal shelter that houses stray and unwanted animals from the unincorporated areas of the South Western Region of Riverside County. The animals are delivered to the facility pursuant to mandates set by the State of California and County Ordinances No. 630, 534, and 716.

The County of Riverside Board of Supervisors approved the Agreement with Lake Elsinore Animal Friends (now known as Animal Friends of the Valley) on November 28, 1995, item 3.20 for the performance period of July 1, 1995 through June 30, 1997. A new agreement was drafted and approved by the Board of Supervisors on November 10, 1998, item 3.31 for the performance period of July 1, 1998 through June 30, 2001.

In March 6, 2002, County Purchasing Department issued a Request for Information (RFI) #97808 to find other animal shelters servicing the South Western Region of Riverside County. There was no response from vendors to the RFI which resulted in a new agreement with Animal Friends of the Valley; approved by the Board of Supervisors on July 31, 2001, item 3.11 for the performance period of July 1, 2001 through June 30, 2004.

To comply with County of Riverside policy, the Department of Animal Services is initiating a request for proposal (RFP) for animal shelter services. It is expected to be completed by June 30, 2005. To avoid interruption of current services, the Community Health Agency is requesting that this Amendment be approved one more year upon RFP completion.

PRICE REASONABLENESS: Animal Friends of the Valley was the only vendor that responded to an RFI in 2002 and was awarded the contract by the Board to service the South Western Region of Riverside County. Animal Friends of the Valley have agreed to maintain the existing contract rate of \$33.00 per animal for the new contract period.

This Amendment was approved as to form by County Counsel.
