**SUBJECT:** Radiation Oncology Medical Services Agreement between the County of Riverside and Palm Imaging Institute, Inc.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Radiation Oncology Medical Services Agreement effective July 1, 2004;
- 2) Authorize the Chairperson to sign four (4) copies of the agreement; and
- 3) Retain one (1) copy and return three (3) copies of the executed agreement to Riverside County Regional Medical Center (RCRMC) Administration for distribution.

**BACKGROUND:** Radiation Oncology services are not currently performed on-site at Riverside County Regional Medical Center. Therefore, the hospital sought to obtain Agreements with geographically diverse centers that are specially trained, competent and maintain the necessary specialized radiation therapy equipment for patient referrals. Radiation Oncology services are a requirement of the Hospital's MISP Program and must be readily available for the MISP patients requiring this type of specialized medical care.

Palm Imaging Institute maintains the necessary specialized radiation oncology equipment to provide Standard Radiation Therapy, Brachytherapy and Intensity Modulated Radiation Therapy (IMRT) services for patients referred for these specialized medical care services.

This Agreement has been reviewed and approved by County Counsel.
