

RECOMMENDED MOTION: **APPROVE** the Cooperative Agreement between the County of Riverside, The Riverside County Flood Control and Water Conservation District, and Cloverdale Marketplace, LLC (Developer); and **AUTHORIZE** the Chairman to execute the Agreement documents on behalf of the County.

BACKGROUND: The Agreement sets forth the terms and conditions by which certain Flood Control facilities, required as a condition of approval for Plot Plan 18477, are to be constructed by the Developer and inspected, operated and maintained by the County and the District.

The Agreement is necessary to provide for District construction inspection of the Eastvale MDP Line D-3 and Eastvale MDP Line D-5, associated with Plot Plan No. 18477.
