**BACKGROUND:** Pursuant to authority conferred upon the CDVA under sections 972, 972.1, 972.2, and 972.5 of the California Military and Veterans' Code, funds may be allocated to a county as reimbursement for a portion of the cost of the County Veterans' Service Officer. Payment of these funds is contingent upon county compliance with the requirements stated in the attached Certificate of Compliance.
