SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT AGREEMENT—EPISCOPAL COMMUNITY SERVICES

RECOMMENDED MOTION: That the Board of Supervisors approves and:

Departmental Concurrence

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program (SHP) Grant for \$231,424 for the period of July 1, 2004 through June 30, 2005.
2. Authorizes the Chairman of the Board to ratify the attached Contract, HU 1662-00, between DPSS and Episcopal Community Services;
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Episcopal Community Services , not to exceed the maximum amount of the Grant Agreement (\$231,424); and
4. Authorizes the Director of DPSS to administer the agreement with Episcopal Community Services.

BACKGROUND:

On July 1, 2003, (Agenda Item 3.49), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a supportive housing program operated by Episcopal Community Services. HUD approved the application and allocated \$231,424 for a 1-year period. Episcopal Community Services provides transitional housing for homeless individuals living with HIV/AIDS.

HUD approved the funding agreement on August 27, 2004, which we are submitting to your Board for approval along with the County's agreement with Episcopal Community Services.
