**BACKGROUND:** After reviewing its contract, the City of Rancho Mirage has elected to delete two Community Services Officer II positions. On September 20, 2004, its City Council authorized execution of the third Amendment to its Agreement for law enforcement services with the County to reflect this new level of service. County Counsel has approved the Amendment as to form.

Sheriff's staff anticipated this city action, and consequently estimated reduced revenues from Rancho Mirage in the FY 2004-05 Department budget.
