SUBJECT: Donation from Century 21 – Lois Lauer Realty

RECOMMENDED MOTION: That the Board of Supervisors: (1) Authorize the Acting Director of Animal Services to accept the donation of \$1,200 from Century 21- Lois Lauer Realty to be used for dog and cat spay/neuter surgeries; and (2) Authorize the Auditor-Controller to adjust the budget as detailed in Schedule A.

BACKGROUND: Century 21 – Lois Lauer Realty, formerly Shelter West Realty, has been an active part of the Inland Empire since 1976. Throughout this time they have supported numerous community programs as the employees nominate an organization each month for which to donate a specific amount of money to be used for the betterment of the community. For the month of September Century 21 – Lois Lauer Realty has elected to donate \$1,200 to the County of Riverside Department of Animal Services to be used for free cat and dog spay/neuter surgeries. These funds will further support the department's mission by helping to reduce the pet overpopulation epidemic in the county.
