SUBJECT: Ratify the Agreement between Riverside County Community Health Agency and the Riverside County Children & Families Commission for the Childhood Asthma Initiative and Tobacco Free Families Agreement No. 04-9334 OP.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Agreement No. 04-9334 OP between Riverside County Community Health Agency Department of Public Health, and the Riverside County Children & Families Commission in the amount of \$1,044,851 for the performance period of July 1, 2004 through June 30, 2005;
- 2) Authorize the Chairman of the Board to sign four (4) copies of the Agreement on behalf of the County; and
- 3) Direct the Clerk of the Board to return all four (4) copies to the CHA Contract Administrator for further processing.

BACKGROUND: The Riverside County Community Health Agency, Department of Public Health has been awarded funding in the amount of \$1,044,851 from the Riverside County Children & Families Commission to improve the management of asthma in children aged 0-5 (Childhood Asthma Program) and provide second-hand smoke education and tobacco cessation counseling for parents of children aged 0-5 (Tobacco Free Families).

These programs have been developed with grant funding from the Commission in previous years, and both involve staff working with clients and their families in their homes. Tobacco Free Families provides tobacco education and cessation services to eligible family members. The Childhood Asthma Program teaches the parents and children about the medications as well as assesses triggers in the home to improve health outcomes related to asthma.
