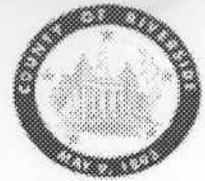

SUBJECT: Grants for Latino outreach program and for cultural programming

RECOMMENDED MOTION: That the Board:

- 1) Accept the *Leer es Triunfar* grant from the California State Library in the amount of \$60,000;
- 2) Accept a grant to the Woodcrest Library from the California Council for the Humanities in the amount of \$1,000.
- 3) Accept a grant to the Robidoux Library from the California Council for the Humanities in the amount of \$1,000.
- 4) Approve the budget adjustments and direct the Auditor-Controller to make the required budget adjustments; and,
- 5) Authorize the County Librarian to execute any required documentation for the above grant awards

BACKGROUND: The County Library has received funding for the *Leer es Triunfar* outreach program to the Latino community since 2002. This year's award continues the program for a third year. The two California Council for the Humanities "California Stories Uncovered" awards will enable the Woodcrest Library to present a series of programs highlighting the cultures and ethnic groups in the Woodcrest area and fund programming at the Robidoux Library which celebrates the ethnic diversity of the Rubidoux/Jurupa community and promotes interaction between older residents and high school students.
