SUBJECT: Highway 74/Sultanas Flashing Beacon Project - Award of Contract to Sierra Pacific Electrical Contracting

RECOMMENDED MOTION: That the Board of Directors:

1. Award the construction contract to the low bidder, Sierra Pacific Electrical Contracting in the amount of \$93,470;
2. Authorize the Chairman to execute the contract on behalf of the Board; and,
3. Delegate change order authority to the Executive Director, of the Redevelopment Agency, or his designee in accordance with Board Policy B-11.

Departmental Concurrence

BACKGROUND: On August 10, 2004, the Board of Directors approved the plans and specifications and authorized the Clerk of the Board to advertise the Notice Inviting Bids for the Sultanas/Highway 74 Flashing Beacon Project. The project includes the construction of fire engine warning signs and flashing beacons on Highway 74 near the intersection of Sultanas Road and Highway 74. The signs and beacons will alert Highway 74 traffic (both eastbound and westbound) that emergency vehicles will be entering the area. (Continued on Page 2)

Background: The notice inviting bids for the project was advertised on August 23, 2004. On September 24, 2004 at 3:00 P.M., two bids were received and opened by the Clerk of the Board. After detailed review, County Counsel and Agency staff determined that the low bid, submitted by Sierra Pacific Electrical Contracting, is responsive and complete. Therefore, Agency staff recommends that the Board award the contract to the lowest qualified and responsive bidder, Sierra Pacific Electrical Contracting, in the amount of \$93,470 and approve the project budget as follows:
