SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT AGREEMENT—SHELTER FROM THE STORM

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Housing Program (SHP) Grant for \$249,962 for the period of August 1, 2004 through July 31, 2005.
2. Authorizes the Chairman of the Board to ratify the attached Contract, HU 1661-00, between DPSS and Shelter From The Storm.
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Shelter From The Storm, not to exceed the maximum amount of the Grant Agreement (\$249,962) ; and
4. Authorizes the Director of DPSS to administer the agreement with Shelter From The Storm.

BACKGROUND:

On July 1, 2003, (Agenda Item 3.49), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a supportive housing program operated by Shelter From The Storm. HUD approved the application and allocated \$249,962 for a 1-year period. Shelter From The Storm provides transitional housing for homeless family victims of domestic violence.

HUD approved the funding agreement on July 7, 2004, which we are submitting to your Board for approval along with the County's agreement with Shelter from the Storm to operate the program. Amendments by HUD to the original Grant caused the delay in bringing the attached agreements before the Board.

FINANCIAL DATA: No County General Funds are required.
