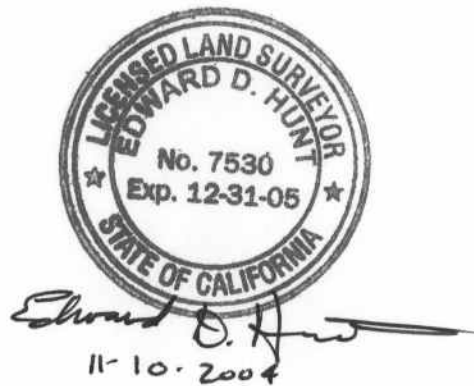

PORTIONS OF THE NEW AND EXISTING ROAD ALIGNMENTS KNOWN AS NEWPORT ROAD, "A" STREET AND PATTON AVENUE THAT MAKE UP THE ROAD REFERENCED AS NEWPORT ROAD ON RIGHT OF WAY MAP ON FILE AS 929-DD IN THE COUNTY SURVEYORS OFFICE. 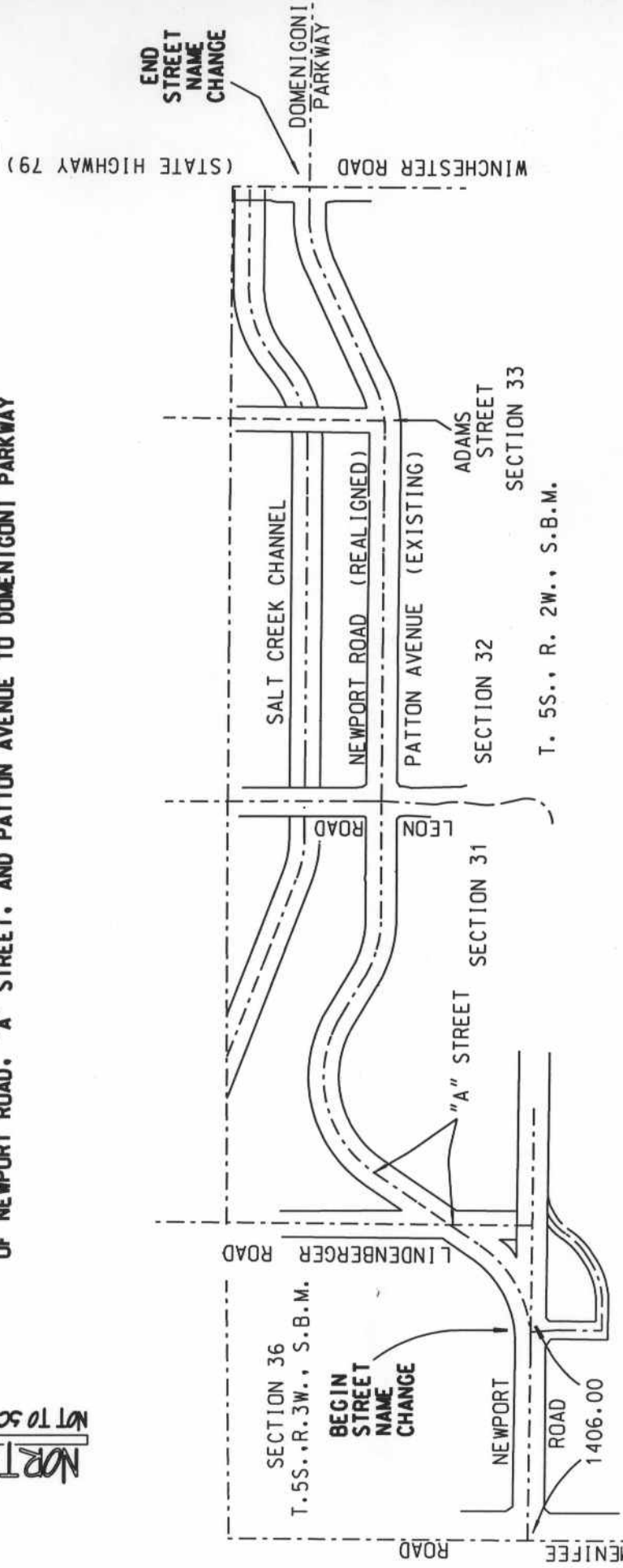
