SUBJECT: Lamb Canyon Landfill Operation Hours

RECOMMENDED MOTION: That the Board approves the changes in hours of operation for the Lamb Canyon Landfill, increasing hours open to all customers by two hours, opening from 6:00 a.m. to 4:30 p.m., Monday through Saturday, and the first Sunday of each month, effective November 30, 2004.

BACKGROUND: County Ordinance 779.5 stipulates that fixing days or hours of operations of County waste disposal sites shall be submitted to the Board of Supervisors for approval before taking effect.

Departmental Concurrence

With the closure of the Edom Hill landfill, Coachella Valley trash will be diverted through the Edom Hill Transfer Station and deposited at the Lamb Canyon, Badlands and El Sobrante landfills. Approximately 50% of the Coachella Valley waste currently disposed of at the Edom Hill landfill could be deposited at Lamb Canyon (as much as 800 tons per day, on average) starting on November 30, 2004. Today's motion adjusts the landfill operations hours at the Lamb Canyon landfill to handle the projected increase in waste and to be consistent with operations hours at the Badlands landfill (currently 6:00 a.m. to 4:30 p.m). Sufficient personnel and equipment, currently at the Edom Hill landfill, will be distributed to both the Badlands and Lamb Canyon landfills to handle the proposed operating hours and increasing waste stream to both sites. In accordance with the Solid Waste Facility Permit for the Lamb Canyon Landfill, the Department has notified the Local Enforcement Agency regarding the anticipated change in hours of operation. In addition, adjusting the hours will not result in any environmental impacts not previously considered as part of the Edom Hill Transfer Station and Lamb Canyon expansion Environmental Assessment.
