

**BACKGROUND:** Attachment "A" lists a Warrant that has been canceled. This warrant was canceled because it was either lost, destroyed, forged, or was not presented to the County Treasurer for payment within the time limitations (six months from date of issue) as provided by law. Pursuant to Government Code 29802 and Board Resolution 82-278, Board approval is required whenever a warrant amount is more than \$10,000.00, or the warrant is more than two and one-half years old.
