

ORDINANCE NO. 835

AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING CERTAIN TIME LIMITATIONS WITH RESPECT TO THE
REDEVELOPMENT PLANS OF THE
REDEVELOPMENT AGENCY FOR THE COUNTY OF RIVERSIDE

The Board of Supervisors of the County of Riverside, State of California, ordains as follows:

Section 1. The purpose of this ordinance is to amend existing Redevelopment Plans of the Redevelopment Agency for the County of Riverside (the "Agency") pursuant to Senate Bill 1045 that became effective on September 2, 2003 as set forth in Sections 33333.2(c) and 33333.6(e)(2)(C) of the California Health and Safety Code.

Section 2. The Redevelopment Plans listed on Exhibit A are hereby amended to extend the time limit for the effectiveness of each Redevelopment Plan by one year and the time limit for the repayment of indebtedness for each Redevelopment Plan by one year, all as set forth on Exhibit A.

Section 3. To the extent not otherwise expressly modified and amended by Exhibit A hereto, all other provisions, covenants, conditions and restrictions of the Redevelopment Plans of the Agency shall remain in full force and effect.

Section 4. This ordinance shall take effect thirty (30) days after the date of adoption.



SUBJECT: Adoption of Ordinance No. 835 Extending the Time Limits on Redevelopment Project Areas

RECOMMENDED MOTION: That the Board introduce the first reading of Ordinance No. 835, an Ordinance of the County of Riverside Amending Certain Time Limitations with Respect to the Redevelopment Plans of the Redevelopment Agency for the County of Riverside.

Departmental Concurrence

BACKGROUND: On September 2, 2003, Senate Bill 1045 was adopted setting forth provisions to allow redevelopment agencies to extend their time limitations for redevelopment activity and the receipt of tax increment by one year. The legislation, as set forth in Section 33333.2 and 33333.6 of the California Health and Safety Code (the "Code") allows a legislative body to extend these time limits to mitigate the effects of the requirement that agencies deposit funds in the Educational Revenue Augmentation Fund (ERAF) in fiscal year 2002-2003 pursuant to Section 33681.9 of the Code. The Agency deposited funds in May of 2003 as required and now recommends that the board adopt the required ordinance to amend the time limits of the project areas to reflect the one year extension.
