SUBJECT: State Standard Agreement Contract Number: ICH02005

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the State Standard Agreement, Contract Number ICH02005, with the State of California Department of Corrections, effective July 1, 2004, through June 30, 2005, for medical services provided to State Inmates at Riverside County Regional Medical Center;
- 2) Authorize the Chairperson to execute four (4) copies of the Agreement;
- 3) Direct the Clerk of the Board to return all four (4) copies of the signed originals to Riverside County Regional Medical Center Administration (upon final approval a fully executed Agreement will be returned to the Clerk of the Board); and
- 4) Direct the Clerk of the Board to hold these contracts as confidential documents, not subject to release under the Public Records Act, and Health and Safety Code Section 1457(c)(1).

BACKGROUND: The State Department of Corrections (SDOC) has extended the terms of their Agreement with the Riverside County Regional Medical Center (RCRMC) to provide inpatient/outpatient, medical and surgical service for an additional year. RCRMC remains the primary hospital provider for the State of California inmates housed at its five (5) correctional institutions located throughout the Inland Empire.

Agreements are submitted late due to extended contract negotiations with the State related to language revisions. This Agreement has been approved as to form by County Counsel.
