BACKGROUND: These portions of Newport Road, "A" Street and Patton Avenue as they are currently named are part of a new road construction project. The alignment of this new road will meet Domenigoni Parkway at the intersection of Winchester Road (State Highway 79). PORTIONS OF THE NEW AND EXISTING ROAD ALIGNMENTS KNOWN AS NEWPORT ROAD, "A" STREET AND PATTON AVENUE THAT MAKE UP THE ROAD REFERENCED AS NEWPORT ROAD ON RIGHT OF WAY MAP ON FILE AS 929-DD IN THE COUNTY SURVEYORS OFFICE. 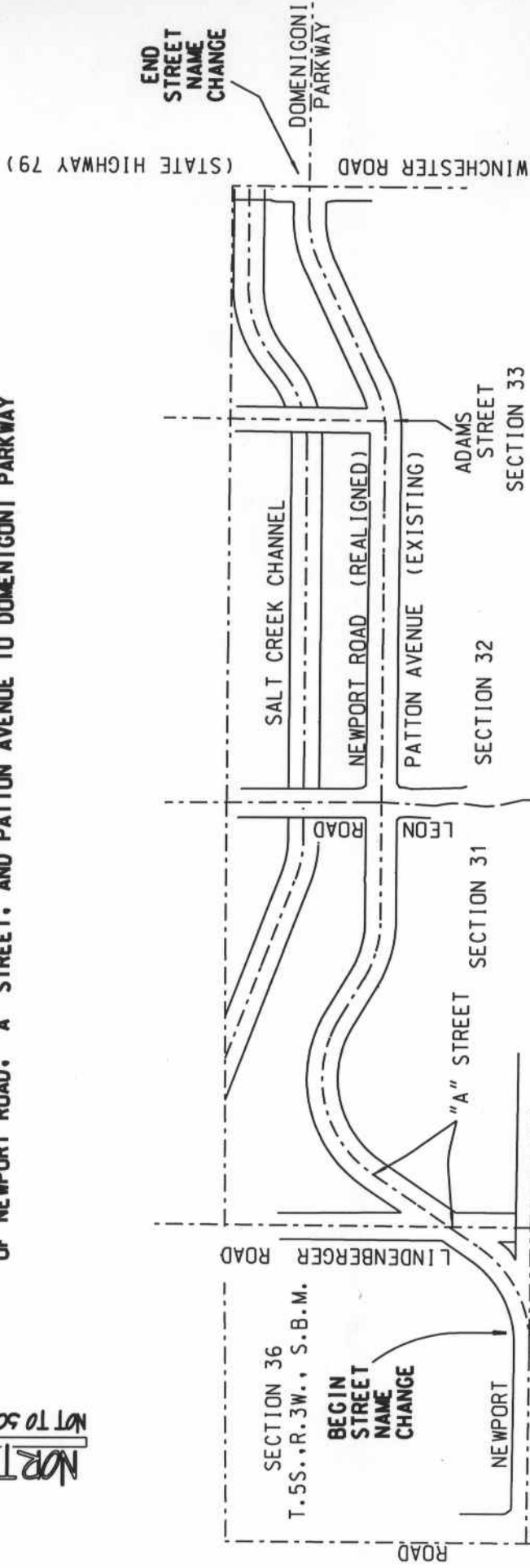
