SUBJECT: INTRODUCTION OF ORDINANCE No. 781.6 regarding the District Attorney's Salary, Amending the Ordinance Establishing Compensation and Benefits for Elected Officials Other than Members of the Board of Supervisors

RECOMMENDED MOTION: That the Board of Supervisors approve the introduction of Ordinance No. 781.6 and adopt the ordinance on the following agenda.

BACKGROUND: The current Memorandum of Understanding with the Prosecution Unit, approved by your Board on June 25, 2002, Item 3.23, provides for a 2.71% step increase for tenured prosecuting attorneys and a 3% cost-of-living adjustment on June 23, 2005. The measure approved the same raises for Management attorneys.

Consistent with Board policy, this proposed ordinance amendment would establish the same pay changes for the elected District Attorney in order to maintain the current minimum 5.5% salary differential with the assistant department head level. The cost of the changes would be borne by the department.

Other independent elected officials are not presently affected by scheduled pay increases.
