Staff is directed to cause the appropriate resolution, based on the election tally, to be prepared and returned to the Board for its consideration.

**BACKGROUND:**

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2004-473 adopted October 26, 2004, the Board of Supervisors noticed a public hearing for December 14, 2004, to receive testimony regarding the annexation of Street Lighting Zone 29 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LM Dist. No. 89-1-C). Annexation of Street Lighting Zone 29 will fund providing electricity for streetlights within the public right-of-ways located easterly of Gunther St.; westerly of Hill St.; northerly of Woburn Ct.; and southerly of Del Norte Wy. In the Palm Desert area and includes 15 lots totaling 8.42 acres.

On October 26, 2004, a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2004-473 and an information sheet was mailed to all property owners within Street Lighting Zone 29 proposed for annexation to L&LM Dist. No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2004-473 in The Press Enterprise at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution No. 2004-473 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two other public locations within the County.

Section 53753 of the Government Code has been amended. It requires that the Board after conducting the public hearing designate an impartial person, having no vested interest in the outcome of the proposed annexation, to tally the ballots received by the close of the public hearing at a specified time, date and place.

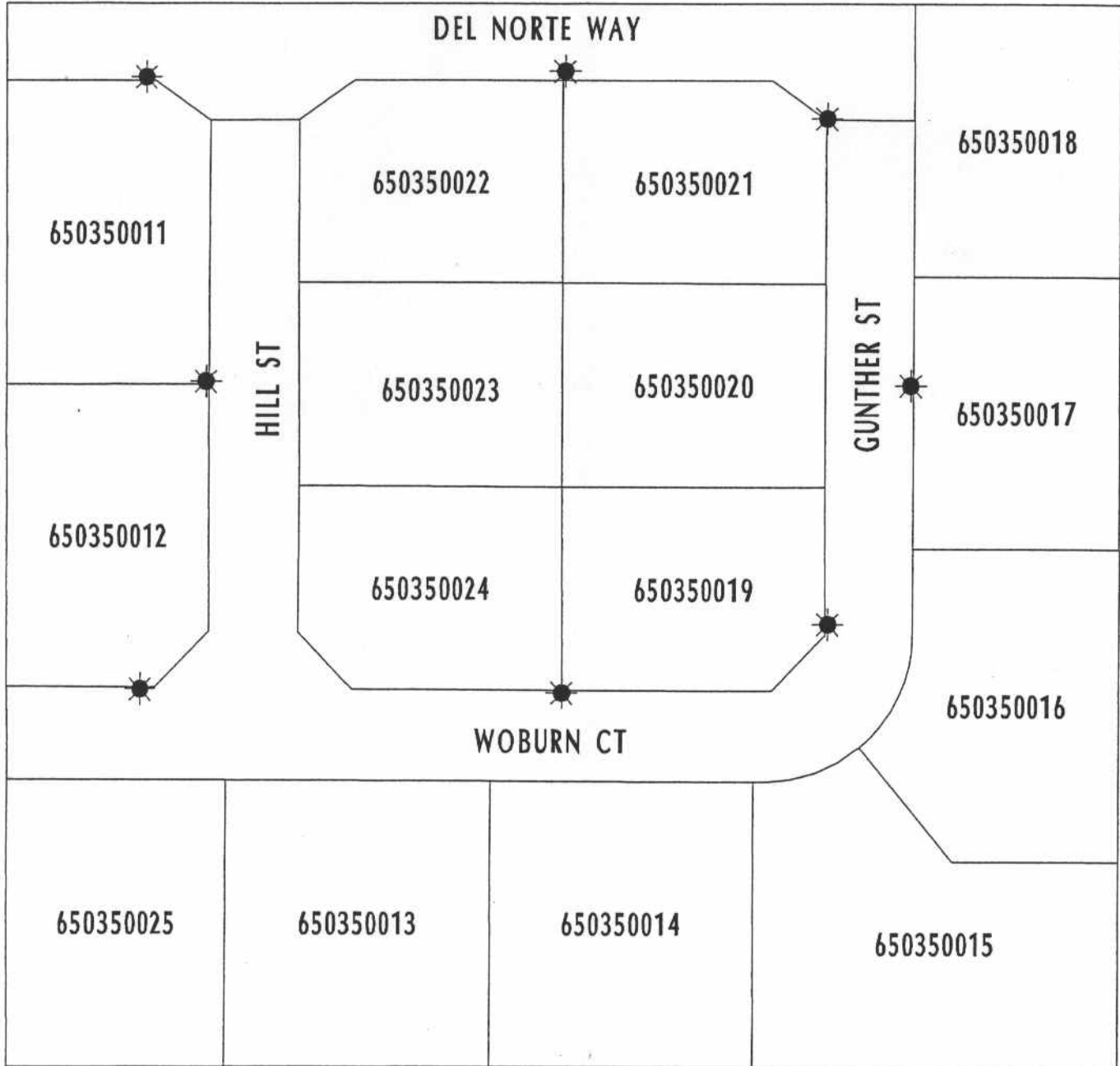
PORTION OF SECTION 18, T.4S.,R.6E.
