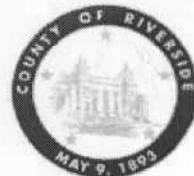

**SUBJECT:** *First 5 Grant for Project Read with Me School Readiness Project*

**RECOMMENDED MOTION:** That the Board:

- 1) Accept the *Project Read with Me* grant from *First 5 Riverside* in the amount of \$153,700;
- 2) Approve the budget adjustments and direct the Auditor-Controller to make the required budget adjustments; and
- 3) Authorize the County Librarian to execute any required documentation for the above grant awards.

**BACKGROUND:** Riverside County Library has been awarded funds from *First 5 Riverside* for *Project Read to Me*, a program which fosters school readiness through one-on-one reading to pre-school children in the home. To date, 950 children have participated in this successful program, which is supported exclusively with *First 5* funds. Acceptance of this funding will allow the program to continue for a third year.

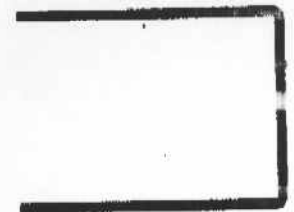
