**BACKGROUND:** The State Department of Mental Health (SDMH) is implementing the Performance Outcomes and Quality Improvement program, which will require counties to report information through the new Performance Outcomes Web-Based Data Reporting System. In order to implement the data collection from all the counties, the SDMH required all the counties to install the ImageNet Scan software through the selected vendor Hershey Technologies. **BACKGROUND (CONTINUED)...**

to have the equipment installed in each county during the month of September, 2004.

Prior to the actual implementation phase, the State imposed a freeze on all equipment by State agencies. This resulted in the SDMH allocating federal funds to Santa Cruz County for the purchase of the hardware and software from Hersey Technologies. Due to a technical problem Santa Cruz County could not purchase all the equipment needed to implement the Performance Outcomes Web-Based Data Reporting System. Santa Cruz County asked Riverside County if we could purchase the equipment (scanners) on their behalf.

The Department of Mental Health made the purchases by working with the department Buyer and followed the County's Ordinance 459, by obtaining three bids for the purchases.

This agreement with Santa Cruz County, Department of Health Services, will reimburse Riverside County for the costs of the equipment that was purchased and distributed to all the counties in the state in order to operationalize the Performance Outcomes Web-Based Data Reporting System.

No additional county funds are required.
