Introduce and adopt on successive weeks Ordinance No. 725.10, an Ordinance of the County of Riverside Amending Ordinance 725, which establishes procedures and penalties for violations of Riverside County Ordinances and provides for recovery of costs reasonably related to enforcement.

That the Board find and declare that the fees authorized by this amendment do not exceed the estimated reasonable cost of providing the associated services and regulatory activities.

That the Board find and declare that the fees authorized by this amendment are reasonable and that these fees represents costs incurred by the County that will result in fair and equitable cost recovery.

**BACKGROUND:** This amendment to Ordinance 725 will reflect the increase in hourly rates for Building and Safety Code Enforcement Officers and Technicians and other department staff. The rates have been approved by the Auditor-Controller's Office.
