**BACKGROUND:**

On March 20, 2001 (Agenda Item 3.26), your Honorable Board approved a grant agreement for \$736,945 between HUD and DPSS to run a Supportive Housing Program. On September 25, 2001 (Agenda Item 3.34), your Honorable Board signed an agreement with Valley Restart Shelter to run the project from April 1, 2001 through three years after the start of supportive services, which expired on October 31, 2004.

On December 10, 2004, HUD approved an Amendment requested by DPSS to reduce the funding from \$736,945 to \$362,727, and to extend the grant period from October 31, 2004, through February 28, 2005, which we are submitting to your Board for approval. This Amendment was necessary because Valley Restart was unable to start the project as planned and could not expend all of its funding. The effective date of the change is May 13, 2004.

DPSS anticipates a renewal of the expired project, which will continue to provide homeless services to dual diagnosed homeless individuals with disabilities. Valley Restart's intention is not to continue with the renewal project. Therefore, DPSS will solicit a new sponsor to continue the renewal project.

**FINANCIAL DATA:** No County General Funds are required.

The total budget reductions for the four (4) fiscal years are broken down as follows: Year 1 – (\$157,948) FY 01/02; Year 2 – (\$233,147) FY 02/03; Year 3 – (\$30,102) FY 03/04; and Year 4 – \$46,979 FY 04/05. The total reduction amount is (\$374,218).
