**SUBJECT:** Recommendation for Distribution of Excess Proceeds for Tax Sale No. 167, Item 553.  
Last assessed to: Richard L. Curtis and Rochelle D. Curtis, Trustees of the Curtis Revocable Family Trust dated August 5, 1987.

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve the claim from Global Discoveries, Ltd., agent for Rosemarie McCormack for payment of excess proceeds resulting from the Tax Collector's public auction sale associated with parcel 378285003-4;
- 2) Authorize and direct the Auditor-Controller to issue a warrant to Global Discoveries, Ltd., agent for Rosemarie McCormack in the amount of \$5,423.12, no sooner than ninety days from the date of this order, unless pursuant to the California Revenue and Taxation Code Section 4675, an appeal has been filed in Superior Court.

**BACKGROUND:** In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 17, 2003 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 14, 2003. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 13, 2003, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received one claim for excess proceeds:

- 1) Claim from Global Discoveries, Ltd., agent for Rosemarie McCormack based on an Assignment of Right to Collect Excess Proceeds dated September 17, 2003 and based on a Gift Deed recorded August 14, 1987 as Instrument No. 235113 and an Affidavit for Collection of Personal Property under California Probate Codes 13100-13106.

Pursuant to Section 4675 (a) & (b) of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, Ltd., agent for Rosemarie McCormack be awarded excess proceeds in the amount of \$5,423.12. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion.
