SUBJECT: Ratify Agreement between the State Department of Health Services, Children's Dental Disease Prevention Program and the County of Riverside Community Health Agency.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Agreement No. 04-35484 for the Children's Dental Disease Prevention Program funded by the State of California for Fiscal Years 2004/05 through 2006/07 in the amount of \$125,429 (annually); and
- 2) Authorize the Chairperson to sign eight (8) originals of said Agreement on behalf of the County.

BACKGROUND: The Children's Dental Disease Prevention Program provides dental health education and dental sealant placement to children in schools in which a minimum of the student body qualify for the Free and Reduced School Lunch Program. This program is an important tool in combating the high dental disease rates in Riverside County's children. Surveys last year showed 83% of children screened had existing or prior dental disease. This program funds the provision of education to 12,543 students and sealant placement for 377 students. The Board of Supervisors gave approval to the Children's Dental Disease Prevention Program to seek this funding on 7/13/04, item 3.11.

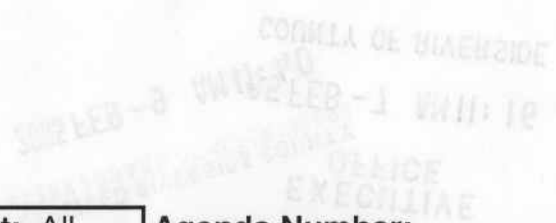
