**BACKGROUND:** Attachment "A" lists a Warrant that has been canceled. Pursuant to Government Code 29802 and Board Resolution 82-278, Board approval is required whenever a warrant amount is more than \$10,000.00, or the warrant is more than two and one-half years old.
