SUBJECT: Resolution 413-581 to Establish a No-Parking Zone on Garfield Avenue and No-Stopping Zones on Center Street and Garfield Avenue, Highgrove area

RECOMMENDED MOTION: That the Board adopt Resolution 413-581 to establish a No-Parking Zone on Garfield Avenue, and the No-Stopping Zones on Center Street and Garfield Avenue in the Highgrove area, as described in attached Resolution 413-581.

BACKGROUND: The Principal of Highgrove Elementary School contacted Supervisor Ashley's office regarding traffic impacts around the school, specifically during the morning and afternoon drop-off and pickup times.

Transportation Department staff met with the school principal at the location. It was determined that, once the school modifies an existing parking lot for pickup and drop-off, the proposed No-Parking Zone on Garfield Avenue (7:30 a.m. to 3:00 p.m. on school days), and the No-Stopping Zones on both Center Street and Garfield Avenue will be appropriate. These zones will improve the traffic congestion at the school during dismissal time.


The school principal has contacted the Transportation Department on January 6, 2005, and stated that the existing parking lot has been modified.

Based on this review, the Transportation Department recommends approval of these No-Parking and No-Stopping Zones. The Transportation Department staff has contacted the Riverside Area office of the California Highway Patrol regarding the proposed zones.

County Counsel has approved this resolution.

3 ESTABLISHING NO-PARKING ZONES AND NO-STOPPING ZONES
4 IN THE HIGHGROVE AREA

5 BE IT RESOLVED, DETERMINED AND ORDERED by the Board of
6 Supervisors, County of Riverside, State of California, in regular session on

7 March 1, 2005, that pursuant to Ordinance No. 413, the following No-
8 Parking and No-Stopping Zones are hereby established in the Highgrove area:

9 No-Parking Zone

10 On the west side of Garfield Avenue starting at a point 59 feet south of the
11 centerline of Center Street to a point 830 feet south of said centerline, a total
12 distance of approximately 771 feet.

13 This no-parking zone shall be in effect between the hours of 7:30 a.m. and 3:00 p.m. on
14 school days.

17 No-Stopping Zones

18 On the south side of Center Street starting at a point 43 feet west of the
19 centerline of Garfield Avenue to a point 107 feet west of said centerline, a total
20 distance of approximately 64 feet.

21
22 On the south side of Center Street starting at a point 43 feet east of the
23 centerline of Garfield Avenue to a point 140 feet east of said centerline, a total
24 distance of approximately 97 feet.

1 On the south side of Center Street starting at a point 249 feet east of the
2 centerline of Garfield Avenue to a point 386 feet east of said centerline, a total
3 distance of approximately 137 feet.

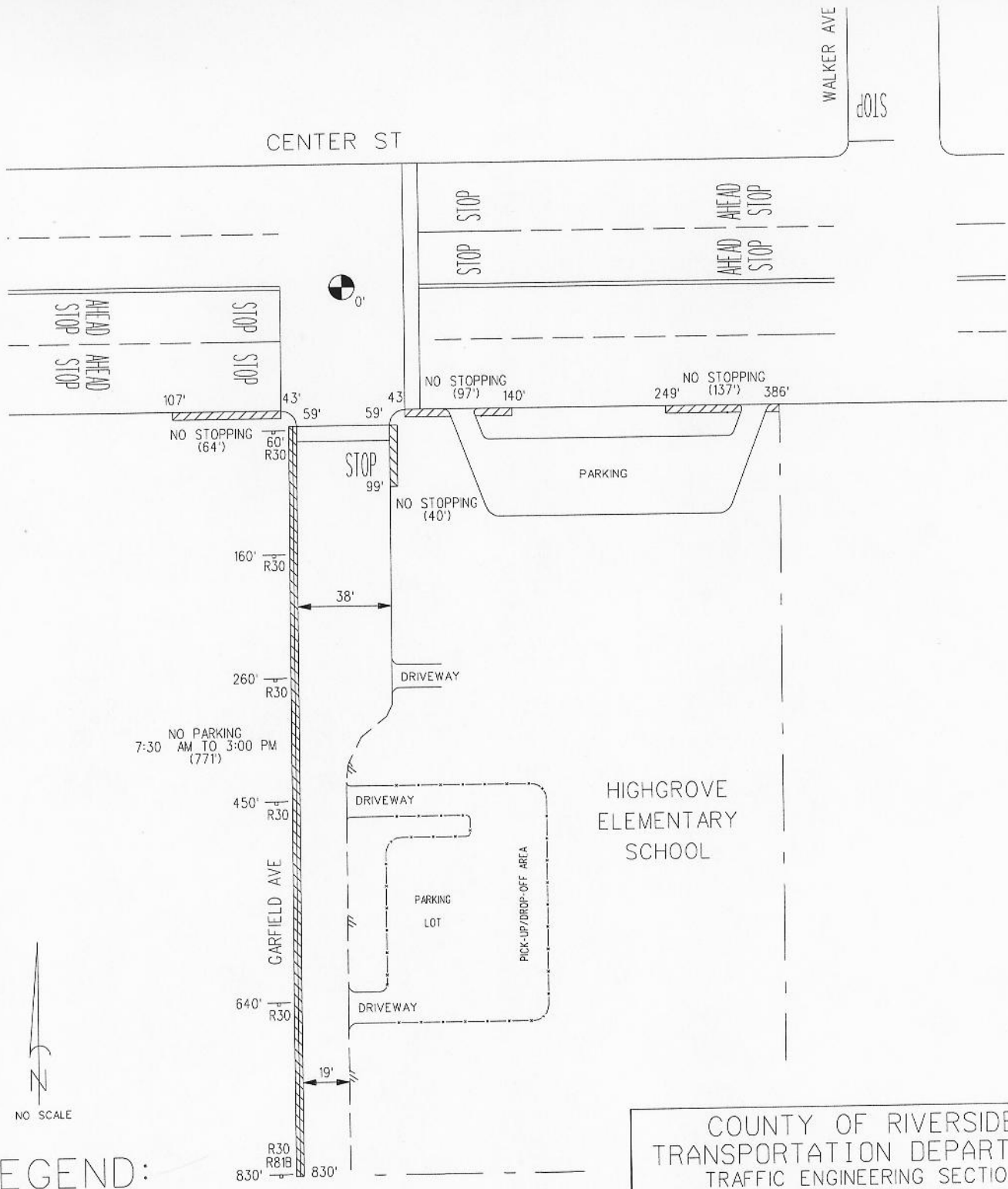
5 On the east side of Garfield Avenue starting at a point 59 feet south of the
6 centerline of Center Street to a point 99 feet south of said centerline, a total
7 distance of approximately 40 feet.



