**RECOMMENDED MOTION:**

Approve the Cooperative Agreement between the District, the County of Riverside and Hearthstone Multi-Asset Entity A, L.P. (Developer); and authorize the Chairman to execute the Agreement documents on behalf of the District.

**BACKGROUND:**

The Agreement sets forth the terms and conditions by which certain stormwater drainage facilities, required as a condition for approval of Tract No. 31386, are to be constructed by the Developer and inspected, operated and maintained by the District and County. The Agreement is necessary to formalize the transfer of necessary rights of way and to provide for District construction inspection of the Eastvale MDP Lateral D-1, Stage 2 associated with Tract No. 31386. Upon completion of project construction, the District will assume ownership, operation and maintenance of the mainline storm drain. The County will assume ownership, operation and maintenance of the associated catch basins, connector pipes and laterals.
