**RESOLUTION OF THE BOARD OF SUPERVISORS REMOVING AND ADDING
APPLICANT AGENTS FOR THE PURPOSE OF SECURING FEDERAL AND STATE
FINANCIAL ASSISTANCE FOR DISASTERS AND OTHER EMERGENCIES**

BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of Riverside, State of California, in regular session on March 15, 2005, that Craig E. Anthony and Mary Moreland, by virtue of their positions as County Fire Chief and Deputy Director of OES, in accordance with Riverside County Ordinance 533.4 Section 7.2.b., are hereby added to the county list of applicant agents, that is, those authorized to execute for and on behalf of the County of Riverside, applications and documents as may be required by and filed with the State Office of Emergency Services for the purpose of obtaining financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, or state financial assistance under the National Disaster Assistance act. Chief Tom Tisdale and Bonnie Reed are hereby removed from this list because they no longer hold a position making them eligible to be an applicant agent. Brad Harris, Deputy Chief and Larry Parrish, County Executive Officer, hereby remain on the list of applicant agents.
