BACKGROUND: This portion of Chambers Avenue is being mapped over and re-aligned by Tract Map 30705 and Tract Map 31795. The new alignment being built for Tract Maps 30705 and 31795 in this area is the easterly extension of McCall Boulevard from Menifee Road. The developer of these tract maps owns all the property affected by this name change. The Transportation Department recommends approval of this name change.

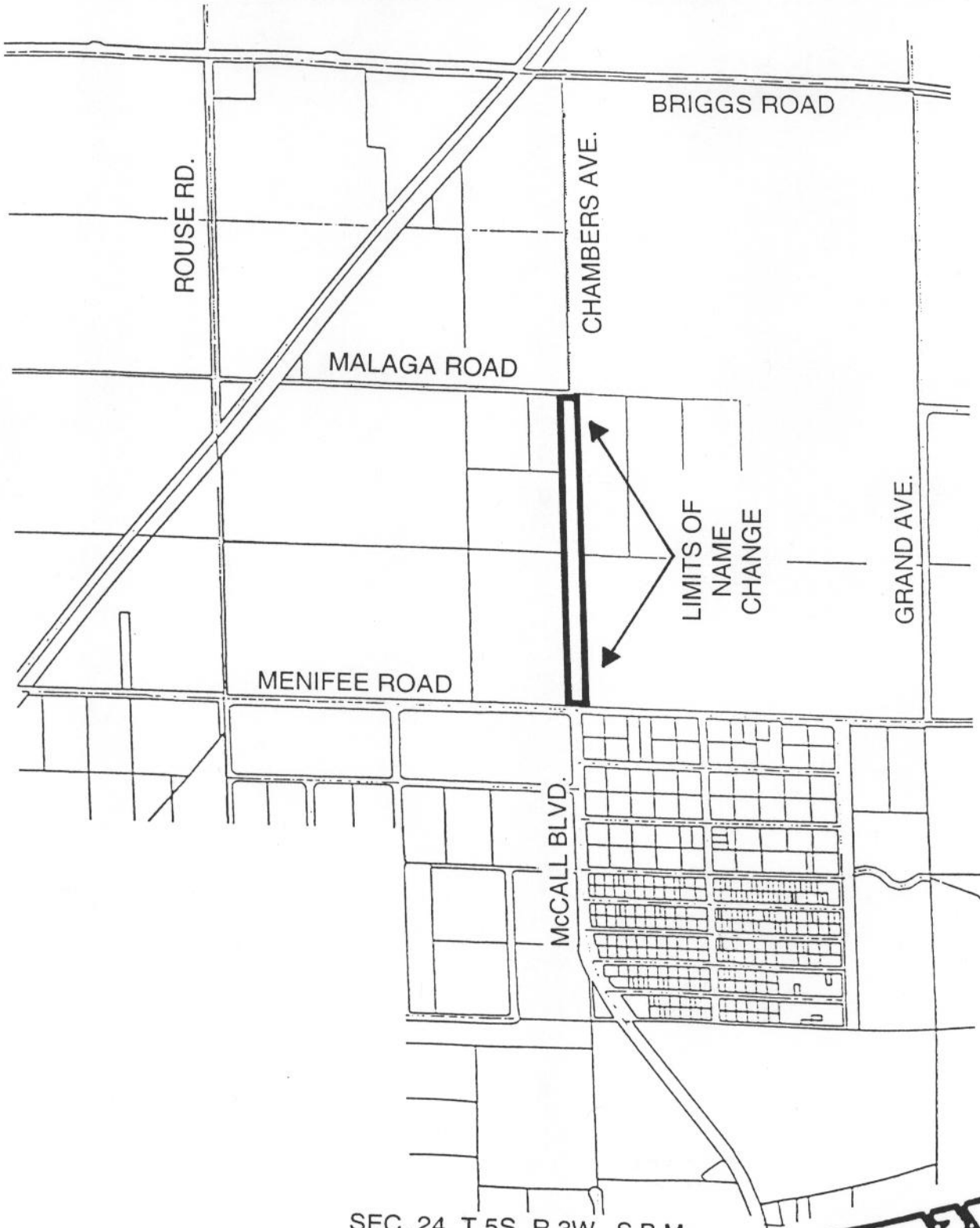
