SUBJECT: Approval of First Amendment to FY 2004/2005 Managed Care Consolidation Agreement between the State Department of Mental Health and the Riverside County Department of Mental Health.

RECOMMENDED MOTION: Move that the Board of Supervisors:

- 1) Approve the First Amendment to FY 04/05 Medi-Cal Managed Care Agreement with the State Department of Mental Health; and,
- 2) Approve Resolution 2005-080; authorizing the Chairman of the Board to execute the First Amendment to this Agreement.

BACKGROUND: On May 25, 2004, item 3.21, the Board approved a Short Doyle (S/D) Medi-Cal agreement, which includes Fee For Service (FFS) Medi-Cal services agreement with the State of California Department of Mental Health for integrated Medi-Cal Managed Care Mental Health services. S/D Medi-Cal targets consumers who are seriously and persistently mentally ill, while FFS consumers traditionally require a lower frequency of services and lower intensity of care. The agreement provides reimbursement for Inpatient Consolidation Services and Specialty Mental Health Services for Riverside County Medi-Cal beneficiaries.

SUBJECT: Approval of First Amendment to FY 2004/2005 Managed Care Consolidation Agreement between the State Department of Mental Health and the Riverside County Department of Mental Health

BACKGROUND (CONT'D.):

The State Managed Care allocation is set annually on a formula basis as determined by the State Department of Mental Health, in consultation with a statewide organization representing counties pursuant to Section 5778 of the Welfare & Institutions Code. Riverside County's FY 04/05 initial allocation was \$7,716,365. This amendment incorporates revised language into the contract to comply with revised regulatory requirements and to revise the interim contract total of \$7,716,365 to add an additional \$554,189 for a revised contract total amount of \$8,270,554.

Approval of this amendment is necessary for Riverside County to receive this allocation. There are sufficient funds in the Department's budget. No County funds are required.
