SUBJECT: Approval of a \$20,000 Private Grant from the Morongo Band of Mission Indians

RECOMMENDED MOTION: That the Board:

1. Authorize the Chief Probation Officer to accept a \$20,000 Grant from the Morongo Band of Mission Indians to Twin Pines Ranch.
2. Approve and direct the Auditor-Controller to make the budget adjustment shown in Attachment A.

BACKGROUND: Late last year Supervisor Ashley's office advised Probation that the Morongo Band of Mission Indians was interested in supporting our work with juveniles at Twin Pines Ranch. A Grant Request Application and letter of interest was forwarded to the Morongo Tribe for consideration.

On February 8, 2005 we received notification of the grant award from the Morongos (Attachment B) and a check for \$20,000. These funds will be used to purchase new kitchen equipment for the culinary arts vocational program at Twin Pines Ranch. A budget for planned expenditures is included as Attachment C.
