SUBJECT: REQUEST FOR ELECTION DATE CHANGE

RECOMMENDED MOTION: That the Board approve Val Verde Unified School District's request for election date change.

BACKGROUND: The Val Verde Unified School District has submitted the attached resolution requesting the Board of Supervisors' approval to change the District's election date from November of odd numbered years to be consolidated with the Statewide General Election held in November of even numbered years.

STATUTORY PROVISIONS: California Elections Code §§ 1302(b) and 10404.5 allow school districts to consolidate their election with the Statewide General Election with the Board of Supervisors' approval. The code further stipulates that the Board shall approve such request unless the ballot style, voting equipment, or computer capability is such that additional elections or materials cannot be handled. With countywide electronic touch screen voting, the Registrar of Voters can accommodate this change of election date.

State law also requires that within 30 days after approval of the resolution, a notice is to be mailed to all registered voters of the District informing them of the change in election date and the terms of officeholders which will be changed. The cost of this mailing will be reimbursed by the District.

RESOLUTION OF THE BOARD OF EDUCATION
OF THE VAL VERDE UNIFIED SCHOOL DISTRICT
ORDERING THE CHANGE OF GOVERNING BOARD MEMBER ELECTIONS
TO EVEN-NUMBERED YEARS

WHEREAS, Education Code Section 5000 and Elections Code Section 1302(a) provide for a regular biennial election to elect members to the Board of Education (the "Board") of the Val Verde Unified School District (the "District"), to be held on the first Tuesday after the first Monday in November of odd-numbered years; and

WHEREAS, as permitted by Elections Code Sections 1302(b)(1) and 10404.5, the District's Board of Education desires to change the above regular election date to the established election date occurring in November of each even-numbered year.

NOW THEREFORE BE IT RESOLVED by the Board of Education of the Val Verde Unified School District as follows:

- 1) The District's present regular election held on the first Tuesday after the first Monday in November of odd-numbered years shall be changed to the established election date occurring in November of each even-numbered year. The District's next regular election to be held on November 8, 2005 shall therefore be held November 7, 2006 upon approval of the Riverside County Board of Supervisors as provided in Elections Code Section 10404.5(d).
- 2) The District Superintendent or designee shall deliver copies of this Resolution to the Riverside County Board of Supervisors, the Riverside County Superintendent of Schools and the Riverside County Registrar of Voters.
