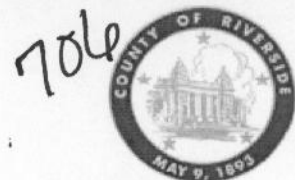

The CSBG Local Initiative Program Agreement provides the core funding for Riverside County's Community Action Program.

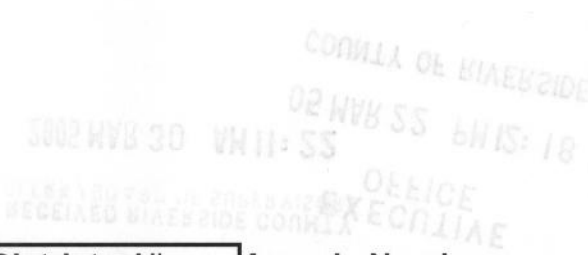
